Success Story:

"Teresa came to the Family Resource Center (FRC) in search of lifestyle changes for herself and her family. She needed assistance in many areas including health insurance linkages, emergency services and counseling. Teresa worked with a case manager at the center who first helped her find affordable health insurance for her two teenage sons, one of whom had special needs and needed unique accommodations in school. Teresa was also linked to an appropriate medical home in her neighborhood for ongoing care.

Teresa admitted to her case manager that she suffered from depression because of an unhealthy marriage. She felt trapped in a downward spiral that she could not pull herself out of without help. Immigration issues and lack of basic needs, coupled with marital discord at home, left Teresa feeling hopeless and helpless. At the center, she began attending counseling sessions and, along with continued assistance from her case manager on her immigration and basic needs challenges, Teresa was able to create and stick to a plan to improve her circumstances. Teresa's goal was to empower herself thereby enhancing her self-worth.

As a result of this drastic change in Teresa, her oldest son began working to improve his life. He volunteered at the center as well as at a local church, finding ways to keep his life busy and enriched. His involvement in positive volunteer activities in the community makes the likelihood that he will join a gang significantly lower than when the family first came to the center for assistance.

Teresa has reached a higher level of self-sufficiency thanks to the services she has received and continues to receive from the center. As she says, "I was not living before, I was just busy. Now I feel alive." She chose to join the Community Action Council (CAC) in order to give back to the community that gave so much to her and, in turn, her family.

Teresa has flourished in her role with the Community Action Council exhibiting great leadership skills. The difference in her life and the lives of those in her family is remarkable and would not have been possible if she had not had the courage to take the first step through the doors of the Family Resource Center."
